## **GINEM** creates awareness in the region

Following the initial launch at Pera in October 2004. GINEM has held two road shows around the region to increase awareness in the business community. The first event was held in Northampton on the 16th March in collaboration with Shoosmiths, Catapult Venture Managers and CMR. Over 60 people from 25 local professional organisations, involved in preparing projects for investment, attended the event.

Kay Williams of Invest Northamptonshire, who attended the launch commented, "GINEM will be a real asset to the county. This member-driven organisation is a great facilitator to enable companies to come together to support entrepreneurs. Often businesses do not know where to go to for help, GINEM is a great signposting web portal".

Also present was Paul Dickinson from Barclays Bank, he said, "GINEM is an interesting and exciting initiative for both investors and entrepreneurs".

The second road show was held in Lincoln on the 18th May. Over 50 people from over 30 professional organisations from around the county were present. We believe GINEM is an initiative which will bring great benefits to many organisations in the region, so were pleased to be involved and to be able to offer our support."
